Approval of Minutes

DIVISION BUSINESS

Website Update: Ms. Lawler informed the Board that its website has been updated to make it more userfriendly and to drive licensees to the website for information.

BOARD BUSINESS

Zero-Based Regulation: Ms. Dunbar reviewed the following sections of the updated redline draft of the rules: Definitions, fees, qualifications for licensure, school program requirements, apprenticeships, establishment inspections, and topics already covered in the statute. She stated that her goal is to make sure the Boards are consistent throughout the Division and to ensure the public is able to understand the rules.
