The meeting was called to order at 9:03 AM by Brad Compton.

#### BOARD BUSINESS

**Approval of Hunting Tag Designations:** Mr. Clifford presented the corrections to tag designations in Regular (Reg) Deer Unit 19, White Tail Deer (WTD) Unit 6, Reg Deer Unit 16, Reg Deer Unit 1, and WTD Unit 21. He also described the designation calculation process for hunts that include a random draw or that have zero historical use.

A motion was made and seconded to approve tag designations for all hunts excluding Regular Deer Units 27, 26, and 20A. The motion carried unanimously.

#### Public Comment:

Mr. Jeff Bitton, Idaho Outfitters and Guides Association, stated his approval and thanks for the timely manner in which tag designations were approved by the Board.

Mr. Ken Barrett, Selkirk Powder Company, stated his intention to secure an outfitter fishing license on the Priest River before the upcoming rule change goes into effect.

#### Executive Session
