Board Meeting Minutes of 8/17/2022

The meeting was called to order at 9:00 AM by Brad Compton.

BOARD BUSINESS

Public Comment: Ms. McFarlane introduced herself as the special events manager for the Idaho Outfitters and Guides Association.

Review Board-Approved Proposed Rules Draft: Ms. Lawler presented the following changes to the Board approved proposed rules:

Rule 003.02 - Hazardous Desert or Mountain Excursions: The list of hazardous activities was reinstated to accurately reflect the list of activities for which a license is required. After suggesting additions to the list, the Board accepted changes to the rule.

Rule 059 - River, Lake and Reservoir Power and Float Outfitter Limits: The Board approved an increase from 2 to 6 Outfitters on the BO2 Boise River. Language was added to sections BL1, SN2, and SN3 that better defines the sections of river and clarifies permit limitations. Language was updated in section SS1 to better define the section of river.

Multi-Party MOU Update: The Board reviewed an updated draft of the Multi-Party MOU and provided direction to Division staff regarding additional revisions.

SNRA Environmental Assessment and Management Plan: The Board discussed the lack of communication and collaboration between the Sawtooth National Recreation Area (SNRA) and the Board. The Board provided direction to Division staff regarding a response to the SNRA.

A motion was made and seconded for Ms. Stark to work with Division staff to draft a response letter to the SNRA for the Board chair's approval and signature. The motion carried unanimously.

Update on 2023 Allocation Including IDFG Temporary Rulemaking: Ms. Lawler gave an update on the Idaho Fish and Game temporary rulemaking. Ms. Lawler also reviewed the tag allocation timeline and stated that the goal is to provide tag designations to all outfitters by November 15th.
