A motion was made and seconded to conditionally approve the use objection by petitioner 8 after verification of four claimed tag numbers. Following discussion, the motion carried unanimously.

A motion was made and seconded to adopt the designation calculations as presented with provisions to account for the outcome of petitioner 8. The motion carried unanimously.
