

MATCHMAKER

All events must have a licensed matchmaker. While there is nothing to preclude a person from holding both promoter and matchmaker licenses, the same person cannot act in both capacities for a single event.

Promoters are responsible for finding and paying the matchmaker for any given event.

> **PROMOTERS ARE RESPONSIBLE FOR...**

SANCTIONING PERMIT

After receiving their Idaho promotor's license, deciding on a venue and a potential date, and securing a licensed matchmaker, a bond or other financial security, and health insurance coverage for all fighters, promoters need to apply for an Event Sanctioning Permit. This is an opportunity for the Commission to review the date, venue, officials, available commission staff, and all other aspects of the promoter's proposed event. If approved, the Commission will issue a permit for the fight.

At the time of the sanctioning permit application, the promoter is also required to pay an initial event tax of \$1,000.

RING OFFICIALS

Every event is required to have licensed ring officials. It is the promoter's responsibility to pay ring officials for their services.

-Referee(s)

-Judges (3)

-Timekeeper

-Ringside Physician

BOND/SECURITY

Promoters must supply a bond payable to the State of Idaho that guarantees the payment of all taxes, fees, and fines including but not limited to the payment of purses to fighters, contributions for required insurance, repayment to ticketholders of purchased tickets, and the payment of fees to ring officials.

HEALTH INSURANCE

Promoters must obtain health insurance sufficient to cover the medical, surgical, and hospital care of every event participant other than the promoter, for injuries sustained while participating in the event.

The insurance shall provide primary coverage for each participant with a minimum coverage of \$10,000 per participant. The participant may not be required to pay a deductible under this insurance.

FIGHTERS & SECONDS

Promoters should work closely with their matchmaker to ensure that every fighter and second they plan to host has turned in the appropriate paperwork at least 14 days prior to the event.

Every fighter must be licensed by the State of Idaho. For reference, every applicant must submit:

- ⇒ A completed and notarized application
- ⇒ \$150 application fee for professional combatants
- ⇒ \$100 application fee for amateur combatants
- ⇒ Blood test for HIV, Hep B surface antigen, and Hep C within six (6) months of the fight
- ⇒ 5 panel drug test by blood or urine within six (6) months of the fight
- ⇒ A full physical completed by a licensed physician within 12 months of the fight

Seconds (cornermen), and managers are required to be licensed in Idaho as well as combatants. Promoters should do everything in their power to ensure that seconds are licensed as far in advance as possible. For reference, every applicant must submit:

- ⇒ A completed and notarized application
- \Rightarrow \$150 application fee

Applications for new second licenses must be received BEFORE the day of the fight.
