Convened: Katie Stuart called the meeting to order at 8:45 MST.

#### **BOARD ELECTION**

Ms. Dye made a motion to elect Mr. Esplin as Board Chair. Ms. Schroeder seconded. Motion carried.

### **APPROVAL OF MINUTES**

# **DIVISION BUSINESS**

Ms. Stuart informed the Board that DOPL's Organization Chart Three is complete and the Division will be moving into Building Four at Chinden in July. Ms. Stuart gave an

update on the 2022 Legislative Session. The Division has had rules approved for the Board and the Division. Governor Little sent the Division Administrator a letter recommending that Health and Welfare's Assisted Care and Facilities Licensing and Certification Department join DOPL for efficiency.

The Board will be reviewing rules as part of the Governor's request for Zero Based Regulations to be presented during the 2024 Legislative Session.

Ms. Stuart that there is a Request for Proposal (RFP) out for the Health Professions Recovery Program which would incorporate all seven health care Boards under DOPL to provide treatment options for licensees.

## **DISCIPLINE UPDATE**

Ms. Stuart stated that there will be no changes to the discipline process and that Investigators will continue to bring cases to the Board.

### **BOARD BUSINESS**

### PT EXAM PROCESS

Ms. Stuart and Jan Arrasmith, Education and Practice Specialist, shared the exam process for bordering states. The Board requested further information on statistics regarding initial exam licensing and denied applications, Ms. Stuart will bring information to the May meeting.

#### LICENSURE REINSTATEMENT REQUIREMENTS

The Board was presented with information from bordering states on how best to demonstrate competency including supervision, fees, meetings with Boards, and CEs. Board staff will review comparison materials and bring back to the Board for review at their next Board meeting.
