Approval of Minutes

ASPPB STATE AND PROVINCIAL SERVICE AWARD

LICENSE REPORT

Ms. Stuart provided the Board with a licensure report which can also be found on the Board's website. Ms. Lotridge stated there are 395 current licensees with an Idaho address.

ZERO BASED REGULATION

Mr. Frost presented to the Board prescriptive authority Rules 700, 701 and 702 which was approved as proposed by the Advisory Panel on 9/7/22. The Board had no questions or concerns. Dr. Napier motioned and Dr. Breitbach seconded to adopt as proposed the entire rule chapter for the Board of

Psychologist Examiners. The vote was Dr. Napier, aye; Dr. Silk, aye; Dr. Breitbach, aye; Senator Darrington, aye; and Dr. Harris, aye. Motion carried unanimously.

Executive Session
