APPLICATION FOR MANUFACTURED HOME PERMANENT FOUNDATION PERMIT

In areas where there is not an approved local building program, whomever (Idaho-licensed building contractor or homeowner) constructs a permanent foundation complying with HUD Federal Regulations § 3285 for a manufactured home must purchase a permanent foundation permit from the Division of Occupational and Professional Licenses (DOPL) prior to the installation of the home.

A home placed upon piers and footings ("standard set") does not require a permit for the foundation. Piers and footings will be inspected as part of the installation permit inspection process.

★ A plan review for the foundation must be completed before the foundation permit can be issued. Submit a .pdf of the foundation plan with your application. This foundation plan must:

New Manufactured Homes: Conform with Part 24 Code of Federal Regulations § 3285.301 (Subpart D - Foundations) and per Idaho Code §44-2201 (use of Manufacturer's Installation Instructions required) in that the foundation plans must be certified and stamped by a Idaho-registered professional engineer or architect;

OR

Used Manufactured/Mobile Homes: The foundation plan must meet the requirements of the Idaho Residential code or shall be designed and stamped by an **Idaho**-registered engineer/architect.
