DRAFT MINUTES OF THE JUNE 28, 2022 IDAHO HVAC NEGOTIATED RULEMAKING MEETING

HVAC Zero-Based Regulations (ZBR)

<u>IDAPA 24.39.70 – Rules Governing Installations of Heating, Ventilation, and Air Conditioning Systems</u> – Today is the first formal negotiated rulemaking hearing to discuss the proposed changes to IDAPA 24.39.70 *Rules Governing Installation of Heating, Ventilation and Air Conditioning Systems*. Informal meetings held previously were intended to gather ideas from stakeholders and identify the pulse as to how HVAC rules are implemented throughout the state. A copy of the redlines were provided, as well as posted on the Division's website. Reviewing the document, the makeup of the HVAC rule chapters consist of amendments to the International Mechanical Code; International Residential Code, parts 5 & 6; and International Fuel Gas Code. In addition to code amendments, the chapter outlines permitting and permit fees for the state's jurisdiction, licensure requirements for HVAC apprentice, journeyman, and contractors, as well as specialty hearth, waste oil heating and fuel gas piping.

Executive Officer Nielsen addressed proposed changes to the following sections and subsections:

000–Legal Authority; 002.03.b & e–Part V (Mechanical) and Part VI (Fuel Gas) of the International Residential Code for One (1) and Two (2)-Family Dwellings; 004.01–Definitions; 011–Contractor and Specialty Contractor Certificate of Competency Requirements; 012–Journeyman Certificates of Competency and Examination Requirements; 013–Specialty Journeyman Certificates of Competency; 014.1–Apprentice and Specialty Apprentice Requirements for Registration; 015–HVAC Waste Oil Heating Specialty Journeyman Certificates Of Competency Limitations: Requirements; 016– HVAC Fuel Gas Piping Specialty Journeyman Certificates Of Competency Limitations: Requirements; 050.01– Permits; 051–Permit Fee Schedule; 053–Civil Penalties; and 053.01–Heating, Ventilation, and air Conditioning Contractor or Specialty Contractor.
