## Licensure by Endorsement for **Military Persons, Veterans and Spouses**

Pursuant to Idaho Code 67-9403 through 67-9406, the Commission is authorized to waive certain licensing requirements and expedite the application for members of the military, veterans, and the spouses of these individuals under the Licensing/Certification Policy for Military Persons.
