Once Uponthe primary source verification of passing the examination is received by the Board, the graduate physician assistant's license will be converted to a permanent license and he may apply for prescribing authority. 0304. No Graduate Physician Assistant Prescribing Authority. Graduate physician assistants shall not be entitled to issue any written or oral prescriptions unless granted an exemption by the Board. Application for an exemption must be in writing and accompany documentation of a minimum of five (5) years of recent practice as a physician assistant in another state.
