#### Approval of Minutes

#### DIVISION BUSINESS

**Executive Agency Legislative Ideas:** Ms. Arrasmith explained the proposed fingerprinting bill would not directly affect the Board until the compact is implemented; the bill would align Division processes for all boards. A proposed licensure renewal bill would transition all professional licenses to renew on the licensee's birthdate every two years.

**Transition to SharePoint:** Ms. Arrasmith informed the Board that they would be using SharePoint to view Board Meeting materials moving forward.

**Board Training – Discipline:** Mr. Spencer reviewed the Division's disciplinary process, including license suspensions, administrative complaints, and hearings.

#### BOARD BUSINESS

##### **Audiology and Speech-Language Pathology Interstate Compact (ASLP-IC) Update & Conference**

**Attendance Report:** Dr. Chaney summarized her attendance at the Annual National Council of State Boards Conference. She stated that she would encourage new Board members to attend future meetings as there was a lot of helpful information for Board members. One topic of discussion was removing the requirement for continuing education, as there is no research to show CE leads to competence. Some other topics included discipline strategies and the use of AI in healthcare. Dr. Chaney stated that the compact has a lot of work to do in order to be fully implemented. They are still working on a tracking mechanism to display members and keep track of discipline.
