Introductions

Approval of Minutes

Respectful Workplace Training: The Committee watched a video presentation from the Idaho Department of Human Resources.

COMMITTEE BUSINESS

Review of Position & Philosophy Statements: The Committee conducted a thorough review of the Board of Nursing's interpretive statements regarding APRNs and the "Guidelines for Best Practice Nurse Peer Review." After careful discussion, it was resolved that staff will collaborate with Ms. Reusser to prepare a final draft. The finalized recommendations will be presented to the entire Committee during an upcoming meeting and subsequently forwarded to the Idaho Board of Nursing for review.

Committee Elections: Following discussion, a motion was made and seconded to elect Ms. Garner as the Committee chair. The motion carried. A motion was made and seconded to elect Ms. Schoenecker as the Committee Vice-chair. The motion carried.

EXECUTIVE SESSION

A motion was made and seconded to authorize the Board Prosecutor to file an administrative complaint should any of the negotiations expire or be rejected. The motion carried.
