# **Approval of Minutes**

A motion was made and seconded to approve the 04/12/2024 minutes. The motion carried unanimously.

#### **DIVISION BUSINESS**

**Licensing System Update:** Ms. Lotridge gave an update on the new licensure system which went into effect July 1, 2024.

**Birthday Renewal Update:** Ms. Lotridge explained the new rules regarding the birthday renewal process to be every two (2) years for the Board of Dentistry licensees which went into effect July 1, 2024.

**School and Association Reports:** The Board reviewed the school and association reports.

**Clinical Exam Discussion:** The Board had a discussion regarding the clinical exam and if licensees who were previously endorsed into Idaho would need to retake the exam or take a refresher course. Ms. Lotridge informed the Board that she would send a survey to CERTA.

**Restorative Endorsement Exam vs. Refresher Course:** A motion was made and seconded to direct DOPL staff to send a letter to licensees on whether they would like their license reissued or waive the rule. The motion carried unanimously.
