<b>Time Out of Active Practice</b>	<b>Requirements</b>
2 years or less	Complete the didactic modules of the Nurse Refresher Program. The Nurse Refresher Program Clinical Faculty Coordinator will assess/determine if recommended clinical hours are necessary (up to 80 hours) based on past clinical experience(s).
More than 2 years but less than 5 years	Complete the didactic modules of the Nurse Refresher Program and supervised clinical experience. A minimum of 80 hours of supervised clinical practice with a registered nurse (may be an LPN if the applicant is an LPN and depending on clinical setting) will be completed with an assessment and recommendation by the preceptor(s).
More than 5 years but less than 10 Years	Complete the didactic modules of the Nurse Refresher Program and supervised clinical experience. A minimum of 120 hours of supervised clinical practice with a registered nurse (may be an LPN if the applicant is an LPN and depending on clinical setting) will be completed with an assessment and recommendation by the preceptor(s).
More than 10 years but less than 15 years	Complete the didactic modules of the Nurse Refresher Program and supervised clinical experience. A minimum of 160 hours of supervised clinical practice with a registered nurse (may be an LPN if the applicant is an LPN and depending on clinical setting) will be completed with an assessment and recommendation by the preceptor(s).
More than 15 years through 20 years	Complete the didactic modules of the Nurse Refresher Program and supervised clinical experience. A minimum of 200 hours of supervised clinical practice with a registered nurse (may be an LPN if the applicant is an LPN and depending on clinical setting) will be completed with an assessment and recommendation by the preceptor(s).

**APPENDIX B – LIC2 SUPPLEMENTAL INFORMATION**

<b>DELEGATED AUTHORITY OUT OF PRACTICE APRN – Authority Idaho Code § 54-1404(4) &amp; § 54-1411(3)(b)</b>	
<b>Time Out of Active Practice</b>	<b>Requirements</b>
Less than 200 Hours of active practice: More than 3 years but less than 5 years	Must complete 200 hours of advanced nursing practice under the direct supervision of fully licensed APRN or physician practicing in the same specialty practice area as that of the applicant. At the completion of the supervised practice, the supervising practitioner will submit a statement assessing the applicant’s knowledge and practice ability in support of issuance of the renewable license.
More than 5 years but less than 10 years	Must complete at least 300 hours of advanced nursing practice under the direct supervision of a fully licensed APRN or physician practicing in the same specialty practice area as that of the nurse seeking licensure. At the completion of the supervised practice, the supervising practitioner will submit a statement assessing the applicant’s knowledge and practice ability in support of issuance of the renewable license.
More than 10 years	Must submit an assessment of knowledge and clinical ability as well as a plan for remediation for consideration by the APRN advisory committee of the Board. The advisory committee shall recommend a course of action for consideration by the Board.

**APPENDIX C – LIC3 SUPPLEMENTAL INFORMATION**

**LATE RENEWAL REINSTATEMENT FEES AND FINES – Authority Idaho Code § 54-1404(8) & § 54-1411**

When a nurse has failed to timely renew his or her license but has continued to practice nursing, the graduated administrative fines for untimely renewals shall be as follows:

- An administrative fine of \$25.00 for the first 30 days.
- An administrative fine of \$50.00 for 31 to 60 days.
- An administrative fine of \$100.00 for 61 to 90 days.
- An administrative fine of \$100.00 and a referral for disciplinary action for 91 or more days.

For any subsequent failure to timely renew a license, with continued practice of nursing, the graduated administrative fines for subsequent failure to renew shall be as follows:

- An administrative fine of \$50.00 for the first 30 days.
- An administrative fine of \$100.00 for 31 to 60 days.
- An administrative fine of \$100.00 and a referral for disciplinary action for 61 or more days.

3 years through 5 years	Complete the didactic modules of the Nurse Refresher Program and supervised clinical experience. A minimum of 80 hours of supervised clinical practice with a registered nurse (may be an LPN if the applicant is an LPN and depending on clinical setting) will be completed with an assessment and recommendation by the preceptor(s).
More than 5 years but less than 10 Years	Complete the didactic modules of the Nurse Refresher Program and supervised clinical experience. A minimum of 120 hours of supervised clinical practice with a registered nurse (may be an LPN if the applicant is an LPN and depending on clinical setting) will be completed with an assessment and recommendation by the preceptor(s).
More than 10 years but less than 15 years	Complete the didactic modules of the Nurse Refresher Program and supervised clinical experience. A minimum of 160 hours of supervised clinical practice with a registered nurse (may be an LPN if the applicant is an LPN and depending on clinical setting) will be completed with an assessment and recommendation by the preceptor(s).
More than 15 years through 20 years	Complete the didactic modules of the Nurse Refresher Program and supervised clinical experience. A minimum of 200 hours of supervised clinical practice with a registered nurse (may be an LPN if the applicant is an LPN and depending on clinical setting) will be completed with an assessment and recommendation by the preceptor(s).
