

As part of our ongoing efforts to improve efficiency and better serve you, we recently implemented our new licensing system, Oasis. Alongside the launch of Oasis, we have discontinued printing and mailing physical license cards. Instead, license cards are now issued as a digital file which allows you to save copies to your phones and other electronic devices. Our decision to move licenses to a digital format provides quicker access to your license. However, if you prefer having a physical copy you can also print them at home.

Once your license is approved, the system auto-generates an email the following business day from DoNotReply@dopl.idaho.gov which contains a link where you can download your license. The link will download a two-page PDF, and the license is the second page of this document, which will look like this:
