Manufactured Home Installation Tags – 687 Manufactured Home Installation Permits – 364 Manufactured HUD Permits – 51 Modular Building Permit and Insignia Requests – 8,997 Manufactured Home Manufacture License – 27 Manufactured Housing – 334 Manufacturer – 612 Future meetings will offer more detailed information, including separate categories for Modular Building permits and insignia requests, clarification on whether the permits apply only in Idaho or across the Tri-State area, and distinct groupings for each permit type within the broader categories.

**Review of the Checklist:** Lisa Stover, Building Program Supervisor, presented the New HUD Manufactured Home Checklist and Used Mobile/Manufactured Home Checklist at IDABO's recent meeting. They have also been sent to stakeholders for input. The Board will collaborate with Division staff to refine and edit the checklists, incorporating feedback from the industry.
