Memo: Rite Aid Closure Expedited Temporary Licensure Pathway

Rite Aid operates more than 1,200 pharmacies nationwide which were responsible for more than 125 million prescriptions per year. The recent bankruptcy filing and anticipated closures are expected to result in significant patient displacement and increased demand on surrounding pharmacies and healthcare providers within Idaho. In preparation for the upcoming Rite Aid pharmacy closures which begin this week, the Division of Occupational and Professional Licenses is taking proactive measures to help ensure continuity of care for patients and to support pharmacy operations throughout the state. Any pharmacist or pharmacy technician looking to practice in or into the state of Idaho to help mitigate for the anticipated demands are encouraged to seek licensure via a temporary expediated pathway.

Pharmacists applying for expedited licensure will be required to complete the following:

- Obtain an Idaho Rite Aid Closure Assistance Verify credential
 - o NABP FAQ: https://nabp.pharmacy/help/categories/nabp-verify/
- Apply for an Idaho license through the <u>Idaho DOPL website</u> (Online Service) applicants must sign up for a new "Online Services" account.
 - When completing the online licensure application be sure to choose the obtain by method of "Reciprocity."
 - o The following are required when applying for a licensure:
 - Idaho PDMP Registration Pharmacists must initiate registration with the Idaho Prescription Drug Monitoring Program. Registration can be completed <u>here.</u> New applicants must enter "pending" when prompted for your Idaho license/registration number.
 - A current government issued photo ID.

Technicians applying for expedited registration will be required to complete the following:

- Apply for an Idaho technician registration through <u>Idaho DOPL website</u> (Online Service) applicants must sign up for a new "Online Services" account.
 - o Only one application type exists for pharmacy technicians in Idaho.
 - o The following are required when applying for a registration:
 - A current government issued photo ID.
- Employers must submit a list of eligible applicants and authorized individuals who can update the technician list to nicki.chopski@dopl.idaho.gov to receive expediated review.
 - o Title the email: Rite Aid Pharmacy Closure Employer Technician List

All licenses and registrations issued through this expedited process expire September 30, 2025. Licensees that anticipate needing to work in Idaho beyond September 30, 2025, are encouraged to utilize the standard reciprocity pathway through NABP e-LTP.

Frequently Asked Questions:

Pharmacists:

- Approximately how long will the expedited licensure take?
 - o For pharmacists that obtain the NABP Verify Credential, the process is expected to take two business days.
- Who can apply for expedited licensing through NABP Verify?
 - Any out-of-state pharmacists with an unencumbered license in good standing in their home state entering Idaho to assist communities impacted by the Rite Aid closures on a short-term basis.
- How long is this expedited license good for?
 - All licenses and registrations issued through this expedited process expire September 30, 2025. Licensees that anticipate needing to work in Idaho beyond September 30, 2025, are encouraged to utilize the standard reciprocity pathway through NABP e-LTP.
- What duties can the newly licensed pharmacists and pharmacy technicians perform?
 - Pharmacists and pharmacy technicians are expected to practice within the Idaho Board of Pharmacy's statute and rules which can be found on the Idaho DOPL website here:

- Is a PDMP login required for pharmacists?
 - o Yes, this free account takes approximately one minute to establish.
 - To register for a PDMP account: <u>Idaho Prescription Monitoring Program</u>.
 - For questions regarding PDMP registration: Idaho PDMP FAQ.
- Will this option be extended to hospital or clinic staff pharmacists?
 - There is no limit on practice setting. A hospital or clinic that desires to bring in out-of-state pharmacists with unencumbered licenses in their home state for the specific purpose of assisting with the Rite Aid closures are welcome to do so following the same process as outlined above.
- Can I be disciplined in Idaho?
 - As a holder of an Idaho license, you are subject to the disciplinary and penalty provisions found in Idaho Code.

Technicians

- Can pharmacy technicians also apply for expedited registration?
 - Yes, pharmacy technicians are also eligible to apply, however the process differs from pharmacists.
- Approximately how long will the approval process take?
 - Issuance of a temporary license for pharmacy technicians will likely take two business days but may take longer since they cannot obtain a NABP Verify Credential.
- Can technicians be PDMP delegates?
 - o Yes, technicians are eligible for an Idaho PDMP login and may act as a delegate.
- Can I be disciplined in Idaho?
 - As a holder of an Idaho registration, you are subject to the disciplinary and penalty provisions found in Idaho Code.
