The meeting was called to order at 9:11 AM (MT) by Chair Tom Mullen.

Approval of 04/30/2024 & 02/04/2025 Minutes

A motion was made and seconded to approve the April 30, 2024, and February 4, 2025, meeting minutes. The motion carried unanimously.

DIVISION BUSINESS

Financial Report: Executive Officer (EO) MiChell Bird provided the 2025 Fiscal Year Financial Report for the Board of Registration of Professional Geologists.

New Survey: EO Bird informed the Board of a revised version of the Board Meeting Evaluation Survey used by Board members to submit feedback on their experiences to the Division.

Open Meeting Law Training: The DOPL 2025 Open Meeting Law Training was presented to the Board by Legal Counsel (LC) Gus Tate.

House Bill 14 Discussion: [House Bill 14](#), The Idaho Code Cleanup Act, requires state agencies to review their titles and chapters of the Idaho Code for unnecessary, obsolete and outdated provisions and provide a report to the Legislature by September 1, 2025. LC Tate reviewed [Idaho Code § 54-28](#) with the Board and noted that if any of the Board's comments affect the overall report, he would follow up with Executive Officer (EO) MiChell Bird to determine the next steps

BOARD BUSINESS

Delegation of Authority: LC Tate presented the draft Delegation of Authority – Mutual Recognition Applicants document to the Board. A motion was made and seconded to approve the Delegation to Act on Behalf of the Board – Mutual Recognition Applications as amended. The motion carried unanimously.
