The meeting was called to order at 8:31 AM by David McClusky, MD.

**Approval of Minutes:**

A motion was made and seconded to approve the 02/27/2025 minutes. The motion carried.

**DIVISION BUSINESS**

**Financial Update:** Dr. Chopski presented the financial report for the third quarter of the fiscal year and invited questions from the Board members. The Board's financial report indicated that the Board had a cash balance of \$5,192,366.77 as of 4/10/2025.

**2025 Legislative Update:** Dr. Chopski delivered an update on the 2025 Legislative Session, accompanied by the Legislative Tracker, which offered valuable insights into legislative bills which passed.

Dr. McClusky thanked the Board for the opportunity to serve as the Board chair and formally passed the position to the new chair, Dr. Guzman.

**BOARD BUSINESS**

**Appointments:** The Board reviewed an application for appointment of a public member to the Idaho Allied Health Advisory Board. Following discussion, a motion was made and seconded to appoint Jessica Carman to the open public member position. The motion carried.

The Board discussed the appointment of a of a Board member to the vacant position of IMLCC Commissioner. Following discussion, a motion was made and seconded to designate Dr. Neal. The motion carried.

**Expungement Requests:** Dr. McClusky and Dr. Davis recused from consideration of BOM-2006-5769. The Board then engaged in a discussion regarding the request for expungement of the disciplinary action pursuant to Idaho Code § 67-9314(4). Subsequently, a motion was made and seconded to grant the request. The motion carried.

**Newsletter Review:** The Board engaged in a discussion regarding upcoming newsletters. The Board explored potential future topics, due dates, and designated specific articles for individual Board members to author.

**Conference Attendance and Updates:** The Board discussed attendance at upcoming conferences. Dr. Davis encouraged the Board to send a member to IAMRA in addition to one member of staff. A motion was made and seconded to support upcoming board travel as presented. The motion carried.
