Removal of Conveyance from Active Status

Any conveyance that is to be removed from service must at the minimum have the circuit conductors disconnected from the main disconnect for the conveyance. This requirement applies to elevators, escalators, moving walks, dumbwaiters, material lifts, platform lifts and stairway chairlifts.

Additionally, any conveyance that is to be permanently removed from service or that will be removed for a period of more than three years must also meet the following requirements of ASME A17.1 Safety Code for Elevators and Escalators:

Electric elevator, dumbwaiter, material lift or roped hydraulic elevator:

- 1.) the ropes shall be removed;
- 2.) the car and counterweight shall be at rest at the bottom of the hoistway; and
- 3.) the doors shall be permanently barricaded or sealed in the closed position on the hoistway side.

Hydraulic elevator, dumbwaiter, or material lift:

- 1.) the pressure piping shall be disassembled and a section removed from the premises;
- 2.) the doors shall be permanently barricaded or sealed in the closed position on the hoistway side.

Escalator:

1.) The entrances shall be permanently barricaded.

When the above requirements have been verified by a Division of Occupational and Professional Licenses Elevator Inspector the conveyance will be removed from active status.
