The meeting was called to order at 9:01 AM MT by Vice-Chair Hall.

Approval of 05/20/2026 Minutes:

A motion was made and seconded to approve the May 20, 2026, meeting minutes. The motion carried unanimously.

DIVISION BUSINESS

Financial Report: Executive Officer (EO) Bird presented the Fiscal Year 2026, Quarter 4 Financial Report.

State Travel Policy Update: EO Bird presented a summary of the changes incorporated into the updated Idaho State Travel Policy, which took effect on July 1, 2026.

Universal Discipline Training: Legal Counsel Arroyo provided an overview of House Bill 703, codified at Idaho Code § 67-2616 (Universal Discipline), which became effective on July 1, 2026, including the disciplinary enforcement tools available under the statute.

BOARD BUSINESS

Election of Officers: A motion was made and seconded to elect Board Vice-Chair Hall as Chair. The motion carried unanimously.

A motion was made and seconded to elect Board Member Schalk as Vice-Chair. The motion carried unanimously.

Contractor Education: Education & Training Specialist DeWitt presented the draft Contractor Education E-Learning course. A motion was made and seconded to approve the course with the changes discussed. The motion carried unanimously.

Attorney General Case Referral Report: Investigations Supervisor McClung reported that there were no updates to the referral report, as no new cases have been referred to the Attorney General's office since the previous meeting.

Felony Exemption Process: Licensing Supervisor England reviewed the Board's delegation of authority to the Division for the approval of registration applications involving specific felony conviction circumstances.

Public Comment: There were public comments.

EXECUTIVE SESSION

A motion was made and seconded for the Board to enter into executive session under Idaho Code § 74-206(1)(d) to consider records that are exempt from disclosure under the Idaho Public Records Law Idaho Code § 74-106(9), and Idaho Code § 74-206(1)(f). The purpose of the executive session is to discuss documents relating to the fitness of a licensee to obtain or retain a license or registration and to discuss pending or imminent litigation with the Division's legal counsel.
