**Approval of 03/26/2026 Minutes:**

A motion was made and seconded to approve the March 26, 2026, meeting minutes. The motion carried unanimously.

**DIVISION BUSINESS**

**Financial Report:** Executive Officer (EO) Bird presented the Fiscal Year 2026, Quarter 3 Financial Report.

**Legislative Update:** EO Bird provided an update on the 2026 Legislative Session noting that the Contractor Registration fee increases were approved and will go into effect on July 1, 2026. Additionally, House Bill 703, the Executive Agency Legislation which establishes a Division-wide disciplinary framework, was approved and will go into effect on July 1, 2026. The Contractors Registration Act run by the Idaho Home Builders Association (IHBA) did not receive a hearing in the 2026 legislative session. Any updates regarding whether IHBA intends to run legislation during the 2027 legislative session will be provided at future meetings.

**Contractor Education:** The Contractor Education Course is in the review process and will be provided at a future meeting.

**Attorney General Case Referral Report:** Investigations Supervisor McClung provided the Attorney General Case Referral Report, informing the Board of ongoing or closed cases. This report will be provided at each meeting moving forward.
