**Proposed Rule Amendments:** The Committee reviewed all public comments received by the Division, after which Dr. Duffin presented draft language regarding IDAPA 24.26.01-Rules of Midwifery- Section 200 (Use of Formulary Drugs), Section 203 (Scope and Practice Standards), and Section 102 (Continuing Education Requirements). Following review and discussion, a motion was made and seconded to approve changes to the midwifery rules draft, recommend to the Board of Nursing that they approve the draft rules, and change their status to proposed. The motion carried. Additionally, updated Rule drafts will be posted on the website for the public.

**EXECUTIVE SESSION**

A motion was made and seconded to enter Executive Session pursuant to Idaho Code §§ 74-206(1)(d), 74-106(9), to consider records related to a licensee's ability to obtain or retain a license, which is exempt from public disclosure.
